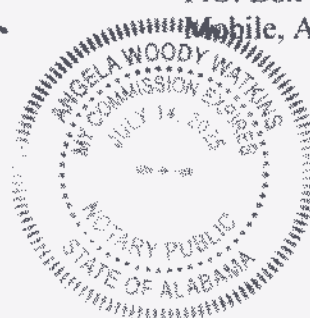
1. The garnishment was issued contemporaneously to the defendant at the last known address available on 10/6/2023 with the service of garnishee and returned by the sheriff/certified mail on 10/10/2023 as no such address (reason for return).
2. A subsequent service was issued on 2/6/2024 to an updated address and it was returned on 4/11/2024, not served.
3. The plaintiff has no new or updated address to attempt service.

As a result of the garnishment issued, the Circuit Clerk is currently in possession of funds that were withheld from the defendant's wages or bank account. The garnishee has filed an answer with the court that the garnishee is in possession of funds or the defendant is employed by the garnishee. These funds cannot be condemned due to the defendant not being served with the Process of Garnishment. In accordance with Act 2022-397, I am hereby requesting by verified motion and filing fee, that this court issue an order for the Circuit Clerk to perfect service on the defendant by posting of the Notice of Garnishment (redacted) and Order to Post on the Clerks Website and a Public Posting at the Courthouse for 4 consecutive weeks. A copy should also be mailed to the defendant at the last known address.
