
VERIFIED MOTION FOR SERVICE BY POSTING OF GARNISHMENT

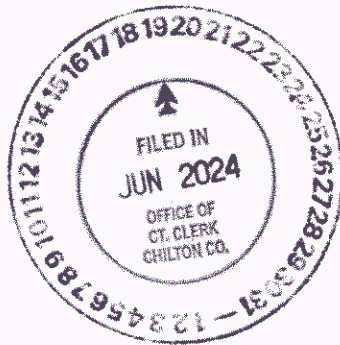
